Kinsidro Grow+ is a lignin based fulvic acid complex complemented with micronutrients intended for professional use on cereals, oilseeds, maize and sugar beet.

Kinsidro Grow+ has a biostimulating effect. It is applied to actively growing plants (see DIRECTIONS FOR USE) and can improve plant quality characteristics through optimising photosystem activity and chlorophyll content and promotes root and shoot development.

Kinsidro Grow+ is used as a foliar spray.

DIRECTIONS FOR USE

Kinsidro Grow+ is designed to be absorbed by the foliage. The product promotes plant quality characteristics by optimising photosystem activity and chlorophyll content.

COMPATIBILITY

Kinsidro Grow+ is soluble in water and its use is compatible with most fertilisers and Crop Protection Products (for further information, consult your supplier). For mixing, add Kinsidro Grow+ into a partly filled mixing tank. Do not apply if rainfall is expected within 3 hours.

DOSE RATE

Apply 150g of Kinsidro Grow+ in 150 to 300L of water per hectare.

APPLICATION

Kinsidro Grow+ is typically applied two times per growing season.

Crop	Dose	Application timing
Maize	150g/ha	GS 12-16
Winter cereals	150g/ha	1 st application GS 12-14, 2 nd application GS 28-32. Optional additional timings GS 39 and/or GS 61
Spring cereals	150g/ha	GS 12-29
Winter oil seed rape	150g/ha	1 st application GS 12-16, 2 nd application GS 28-32. Optional additional timing between GS 51-59
Sugar beet	150g/ha	With 1 st or 2 nd herbicide application

Storage and safety

Store in original package away from direct sunlight and in frost free conditions. Keep out of reach of children. Do not store near food. Do not reuse packaging. Wash hands thoroughly after handling.
